Important Notice (1 of 4)

Please confirm following conditions before use this service.

Delivery area

Limited Ho Chi Minh City

Shipping condition

- Export customs clearance must be completed within 6 months of the shipper's departure.
- The shipper must go to and enter Vietnam. Import customs clearance will be conducted after the shipper arrives in Vietnam.
- "Unaccompanied Baggage Declaration Form" must be submitted to the customs office at the arrival airport at the time of entry into Vietnam.
- Import customs clearance must be completed within the validity period of unaccompanied shipment declaration (within 6 months from the date of declaration).
- Obtaining a work permit. (Import custom clearance can be allowed with the person who will work and obtain a work permit in a company already registered as a legal entity at Vietnam)
- For Vietnamese nationals, the conditions of treatment vary depending on their affiliation.
Students – "Certificate of Enrollment" can be acceptable instead of instead of Work Permit"

Required documents

1) Required document in Japan

- ☐ Copy of passport (ID pages / 1-2 pages with photo)
- ☐ Flight ticket or itinerary from Japan to Vietnam with showing payment method

2) Required documents in Vietnam

- ☐ Unaccompanied Baggage Declaration Form (slit) stamped with Vietnam customs seal
- ☐ Copy of work permit ● ☐ Vietnam working visa ● ☐ Vietnam entry stamp on the passport ●
- ☐ Copy of passport (ID pages / 1-2 pages with photo) ● ☐ Customs clearance power of attorney ◆
- ☐ Copy of certificate of enrollment (only for students of Vietnamese nationality) ●

● mark must be notarized by the customer at a notary public in Vietnam.

If you wish for Yamato Vietnam to be present during the notarization process, please let us know in advance.

A separate fee of 35USD + VAT 10% will be charged by Vietnam Yamato.

◆ mark indicates that the signature of the company representative and the company stamp are required. Students of Vietnamese nationality must sign the form in person. (No stamp is required)

*In case you do not submit Unaccompanied Baggage Declaration Form or have Unaccompanied Baggage Declaration Form without the customs stamp, please let us know.

After the shipper arrives in Vietnam, Yamato Vietnam will contact the "Overseas Contact" you entered during the application. Yamato Vietnam will instruct you about the required documents and custom clearance in the destination. Please follow their instructions.

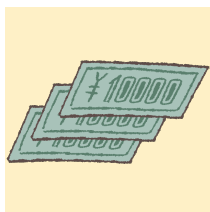

Documents and Books	<ul style="list-style-type: none">• Pornography• Political documents• Magazines with nudity (with hefty fines)
Counterfeiting and Piracy	<ul style="list-style-type: none">• Counterfeited• Pirated goods
Valuables	<ul style="list-style-type: none">• Cash, securities (bills, cheques, gift certificates), precious metals, antiques• Things whose value is difficult to calculate (e.g. items of memorabilia)• credit cards, passports, licences, etc.
Explosives and hazardous materials	<ul style="list-style-type: none">• Explosives (fireworks, gunpowder), high-pressure gas (gas cylinders, spray cans)• Flammable materials (matches, lighters, perfume, cigarettes, cigars, nail polish, de-icer)• Poisonous materials (e.g., chemicals labeled as poisonous or deleterious)• Weapons (handguns, swords *no imitation swords, model guns, stun guns)
Flora and fauna	<ul style="list-style-type: none">• Seeds, bulbs and soil (including soil attached)• Straw products (e.g. goza)• Living plants and animals• Dried flowers
Washington Convention (i.e. Convention on International Trade in Endangered Species of Wild Fauna and Flora)	<ul style="list-style-type: none">• Processed hides/fur/horns/bones/ivory, etc., which are prohibited from trade by the Washington Convention. (furs, rugs, handbags, belts, wallets, accessories, herbal medicines, guitars, ukuleles, etc.)
Pharmaceuticals and Quasi-drugs, etc.	<ul style="list-style-type: none">• Narcotics and psychotropic, etc.• Hypodermic syringes
Electric(al) appliances	<ul style="list-style-type: none">• PCs, monitors, routers, modems, computer peripherals in general, 3D printers• Quantum computers, spectrometers, light sources, hyperspectral cameras, microscopes, gyroscopes, etc.• Drones with components• Transceivers - Antennas for sanitary communication
Other	<ul style="list-style-type: none">• Vehicles (cars, motorcycles, electric bicycles, etc.)• Vessels (canoes, kayaks, rubber boats, etc.)• Rotting materials• Pig Hair Products• Gaming Products
General	Items that cannot be sent without various certificates or approval letters due to laws and regulations.

Important Notice (4 of 4)

Please confirm following conditions before use this service.

Items Subject to Censorship

Vietnam Custom may inspect the goods, and delivery may be delayed or be taken a longer period of time than normal timelines if the shipment is inspected. All items inspected are subject to taxation and will incur a censorship fee. There is no specific regulations regarding the amount of the inspection fee, and the fee may be high. Vietnam Yamato bills you actual amount of tax / duties and inspection fee. Items which the import permit is not granted may be confiscated.

Antique Products	An import license must be required to import antique goods. In case they are imported without an import license to Vietnam, an import permit may not be allowed. If you have antique tableware, wood products, furniture, etc., you must take pictures of them and confirm them with the Vietnamese side in advance.
High-performance Printer	An import license must be required. Inspection fee or/and import tax/ duties may occur depending on the model and whether it is a new or high-performance printer.
Cultural Items	Cassette tapes, floppy disks, CDs, DVDs, MDs, VCDs, videotapes, CD-ROMs, laser disks, books, paintings, game software.

Rainy Season

There is a rainy season (Normally between May and October) in Vietnam. Since this is slightly moldy season, we recommend you to pack dehumidifiers for clothing and shoes if you ship the items during the rainy season.
